The supervisors appointed Benuel Stoltzfus for Planning Commission member.

Diedre Hosier emphasized the importance of keeping Planning Commission term dates easily accessible to everyone.

Darren DeVoe stated he called Helen Esbenshade and PSATS regarding Art Wright's use of a sealed proxy ballot for chair and vice chair for the reorganizational meeting of January 23, 2024. His concern was that the vote may not count if it was not announced prior to the meeting of January 23, 2024. Ed Haas stated that his conversations with them differs from Darren's statement.

Chuck Eggen emphasized and encouraged everyone to be calm and respectful during these disagreements of procedure.

- L. Michael Kauffman (lot add-on plan) Potential deferral of review. Casey Kerschner recommended deferring the plan review to Sadsbury Township, Lancaster County.
 - Ed Haas motioned for the deferral. Ken Umble seconded. Motion carried. Unanimous.
- New Hope Properties, LLC, 5791 Lincoln Highway (preliminary/final subdivision and land development plan) Potential time extension. Jerry Baker of TPD, Casey Kerschner of Becker Engineering, Matt Bush of JMR Engineering, Seth Hiller, Esq. of Blakinger Thomas, Wes Bruckno, AICP of Chester County Planning Commission, and Frank Tavani, P.E. (traffic engineer) who have all been involved in this project made final comments and presentations regarding complying with all necessary engineering in order for DATE OF ACTION OF March 18, 2024. There was much discussion about traffic usage, safety, right of way, and realignment of County Line Road.

Ken Umble motioned to recommend this project to be presented to the Board of Supervisors. Art seconded. Motion carried. Unanimous.
